## The Staff...



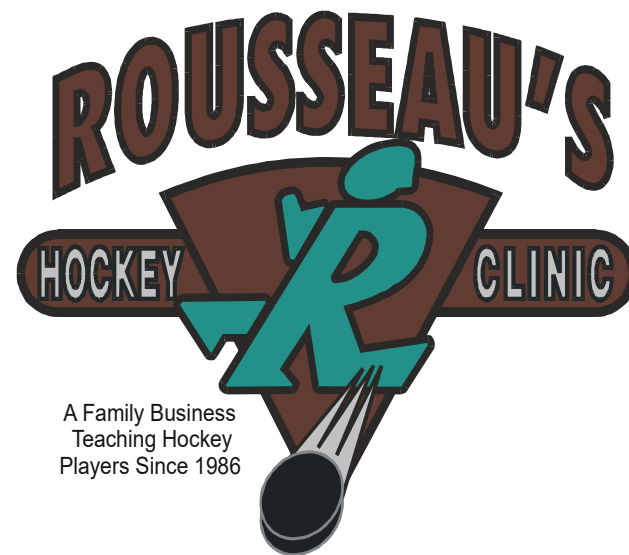

### The Program...

Our Summer Youth clinics offer young hockey players between the ages of 5 and 15 the opportunity to develop fundamental hockey skills and to apply those skills each week in a controlled scrimmage.

We have divided our summer youth clinic into our three core divisions. Each division will skate once a week for a total of seven weeks.

- Junior Division: (ages 5 to 8) - \$320**
- Minor Division: (ages 8 to 12) - \$320**
- Major Division: (ages 12 to 15) - \$320**

Each division will skate two hours per week. The first hour of ice time will consist of fundamental instruction. During the second hour of ice time, we will conduct a controlled scrimmage where we will concentrate on increasing the speed of play and offering individual instruction during playing time. Between hours, we will hold a classroom discussion where we will focus on various topics including: conditioning; mental preparation; and advanced team play.

Our youth clinics will also include instruction specific to goaltenders. We will have a goalie instructor at each session who will work with the goalies on skills specific to the position.

Each division includes 14 hours of ice time, a high quality jersey, and over 100 years combined experience in developing hockey players. A deposit of \$150.00 is due with your application, and the balance is due prior to the first session.

Applications will be accepted on a first come, first served basis and space is limited. We encourage you not to hesitate in returning your applications. Our clinics fill very quickly and we are often forced to return applications. We hope to have the opportunity to train with you this summer.
